I/We hereby make this application to Blanchard Machinery Company ("Blanchard") for credit. If credit is granted, I/We agree to pay all bills in accordance with the stated terms of the sale. A service charge of 1 1/2% per month will be charged on all balances exceeding terms and this charge does not relieve me of my obligation to pay for purchase when due.
