All completed official entry forms must be received by Blanchard Machinery Company on or before 5:00pm November 27, 2009.

Entry forms must be completed in their entirety and are to include a designation as to whether the entrant is a Clemson fan or a University of South Carolina fan. Incomplete or illegible entries will be void. Decisions of the Sponsor are final and binding in all matters relating to the Giveaway.

- ALL entries are subject to verification prior to prize drawing. All entries become the property of Blanchard Machinery Company as the Sponsor and will not be returned or acknowledged.

PRIZES: If both Clemson University and the University of South Carolina win a minimum of eight (8) out of a maximum of twelve (12) regular season games in the 2009 season and also qualify for, accept and win their respective bowl games, the Sponsor agrees to give away two (2) - 277C Caterpillar Multi Terrain Loaders with a bucket and one (1) year or 1500 hour (whichever comes first) warranty. One (1) loader, bucket and warranty will be given to a Clemson University fan and one (1) loader, bucket and warranty will be given to a University of South Carolina fan. Winners will be chosen at random, one from eligible Clemson fan entry forms and one from eligible University of South Carolina fan entry forms.

ODDS: The odds of winning cannot be estimated and will depend on the total number of eligible entries received, the total number of entries by Clemson University fans and the total number of entries by University of South Carolina fans.

HOW A WINNER IS SELECTED: If both of the designated teams win their designated number of games and bowl games, then two (2) winners, one (1) Clemson University fan and one (1) University of South Carolina fan, will be selected in random drawings from the eligible entries. The drawing will be held within forty-five (45) days after completion of both bowl games. Prize winners will be notified in writing by mail at the address shown on the entry form within thirty (30) days after winners are selected. Winners do not need to be present to win. If a winner declines to accept a prize or does not respond within thirty (30) days, or in the event that a prize or prize notification is returned undelivered, the winner will be disqualified and the Sponsor may select an alternate winner at random or may, in its sole discretion, cancel that portion of the Giveaway.
